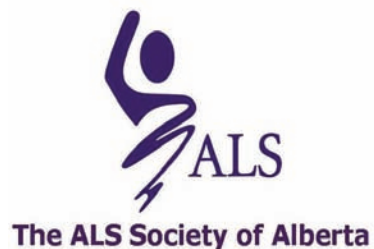

ALS FACTS

- ALS stands for Amyotrophic Lateral Sclerosis, also known as Lou Gehrig's Disease.
- It is a progressive neuromuscular disease, which weakens and destroys the nerves that send messages from the brain to the muscles.
- Paralysis, loss of speech, and inability to swallow or breathe result while the mind remains completely alert and lucid.
- ALS can strike anyone. 2 to 3 Canadians die each day from ALS.
- Life expectancy at diagnosis is 2.5 yrs (avg.)
- A person with ALS can require equipment valued at more than \$40,000. Nursing care can cost several times that amount.
- There is no known cause, cure or treatment that prolongs life significantlyyet.
